

In October 2006, the company announced that it had settled patent litigation with GlaxoSmithKline relating to sumatriptan succinate tablets, the generic version of GlaxoSmithKline Imitrex® tablets. The specific financial terms and conditions of the settlement have not been disclosed. GlaxoSmithKline Imitrex tablets, which



are indicated for the acute treatment of migraine attacks in adults, had U.S. sales of \$1.29 billion for the 12-month period ending December, 2007 according to IMS.
